\$100* COMMERCIAL HIGH-EFFICIENCY TOILET REBATE

NMWD is offering commercial customers \$100* rebates for replacing older, non-water-conserving toilets (those that flush more than 1.6 gallons per flush) with new, EPA WaterSense labeled High-Efficiency Toilets (HET). HETs use an average of at least 20% less water than standard 1.6 gallon per flush toilets.

PROGRAM REQUIREMENTS

Applicants Must:

- Purchase and install a **District approved** High-Efficiency Toilet (HET) between January 1, 2012 and June 30, 2012. To see a list of qualified EPA WaterSense labeled toilets visit http://www.epa.gov/WaterSense/product_search.html
- Own or rent a commercial, industrial, or institutional building within the District's Novato or West Marin Service Areas.
- Call the District's Water Conservation Office for participation details and to initiate the rebate process at **(415) 897-4133 ext. 8711**.
- Agree to a brief pre-installation inspection and post inspection.
- Replace **ALL** toilets that use more than 1.6 gallons per flush in the building or rented space.
- Mail or drop off application with original receipts to District mailing address or office.
- \$100* rebate level good through June 30, 2012 or until funds are depleted. Completed application and receipts must be received by July 15, 2012.

How can I participate?

- Call the District's Water Conservation Office at **(415) 897-4133 ext. 8711** for participation details and to schedule a pre-inspection.
- After contact is made with the District's Water Conservation Office or pre-inspection is complete, replace the toilet(s) with a qualifying HET(s).
- Mail in or drop off application along with original receipt for toilet(s) dated no earlier than January 1, 2012. Application must be **completed and signed**.

- Rebate payment will be mailed to you in 4-8 weeks after application and original receipts are received. Post inspections are randomly requested before rebate is mailed.
