\$150* NON-RESIDENTIAL HIGH-EFFICIENCY TOILET REBATE

NMWD is offering residential customers up to \$150* rebates for replacing older, non-water-conserving toilets (manufactured for more than 1.6 gallons per flush) with new Ultra High Efficiency Toilets (UHET) that use 1.1 gallons per flush (on average for dual flush models) or less. These are more efficient models than the EPA Water Sense rated High Efficiency Toilets currently rebated by NMWD for up to \$100.

PROGRAM REQUIREMENTS

Applicants Must:

- Purchase and install a qualified Ultra High Efficiency Toilet between January 1, 2019 and June 30, 2019. To see a list of qualified models visit www.nmwd.com and refer to the UHET List.
- Own or rent a non-residential property within the District's Novato or West Marin Service Areas.
- Call the District's Water Conservation Office for participation details and to initiate the rebate process at **(415) 761-8944**.
- Agree to a brief pre-installation inspection and post inspection.
- Replace **ALL** toilets that use more than 1.6 gallons per flush in the dwelling. (Customers changing toilets manufactured to flush 1.6 gallons per flush, or new toilets installed after 1993, will not be eligible for rebate)
- Mail or drop off application with original receipts to District mailing address or office.
- \$150* rebate level good through June 30, 2019 or until funds are depleted. Completed application and receipts must be received by July 15, 2019.

How can I participate?

- Call the District's Water Conservation Office at **(415) 761-8944** for participation details and to schedule a pre-inspection.
- After contact is made with the District's Water Conservation Office or pre-inspection is complete, replace the toilet(s) with a qualifying UHET(s).
- Mail in or drop off application along with original receipt for toilet(s) dated between January 1 and June 30, 2019. Application must be **completed and signed**.

- Rebate payment will be mailed to you in 4-8 weeks after application and original receipts are received. Post inspections are randomly requested before rebate is mailed.

***Rebate amount cannot exceed cost of toilet (excluding taxes).**
